It is apprehended that there may be instances of migrant workers travelling concealed in trucks, tankers and other vehicles at the inter-state check posts both inward and outward bound. This is in violation of the orders issued by Ministry of Home Affairs under the Disaster Management Act, 2005.

2. In view of the above, it is advised to check suspicious trucks, tankers and other vehicles at the inter-state check posts both inward and outward bound that may carry migrant workers and turn them back. It is also requested that strong action be taken against such erring drivers and vehicle owners and turn them back.
