ORDER

As you are aware, various measures were undertaken by the Central Government and State Government all over the country for containment of COVID-19 epidemic in the country. Govt. of Mizoram have also issued various measures to prevent the spread of Coronavirus in the State with protocols for implementation of such guidelines.

21-Days national lockdown was effective w.e.f 25.03.2020 and will be in operational upto 14.04.2020. Therefore, we need to take all possible steps to ensure that essential goods supply movement on National Highway are not disrupted throughout the State. It should also be ensured that movement of personal working in the essential services are also not disrupted. For this purpose, the followings need to be ensured by concerned District SP:-

1. It should be ensured that Hotel in between Silchar to Aizawl, Aizawl to Siaha via Lunglei/Lawngtlai, Aizawl to Champhai via Saitual/Khawzawl and Aizawl to Kanhmun via Mamit are functioning/operational so that Truck drivers can take food and this arrangement may be made in liaise with concerned DC and Local Task Force.

2. It should also be ensured that essential goods carrying Truck are given free passage at **Inter-State border** at Vairengte and Kanhmun.

While making arrangements for transit and food at Hotel, the existing protocol of social distancing and all sanitary measures should be strictly adhered to by the Drivers as well as Hotel owners as preventive measure. Necessary guidelines may be given to Hotel owners.

3. It should also be ensured that non-Mizo workers/labours in the District are properly taken care and advise them not to leave their present place of stay till lockdown period is over. Instruction have already been given to all DCs in the District to take care of non-Mizos travellers/workers/labours facing possible problem with regards to lodging, food etc. vide Govt. of Mizoram, DM&R No. B.13021/101/DMR-2020 Dt. 27.03.2020.

Therefore, this arrangement need to be taken care by District Level Task Force under DC in which all SP are also the Member.
