

VISIT REPORT OF DUTY POSTS UNDER CHAMPHAI DISTRICT

1. Tlamsam:

SP Champhai visited the location on 7th April, 2020. Two personnel were on duty on the outskirts of the village around 1.5 kms towards Myanmar border at an important junction. A pitch covered with tent was used as their accommodation which was found to be sufficient even if rain comes. They have good cooperation with the locals. No problems were highlighted by the men on duty.

2. Zote:

SP Champhai visited the location on 7th April, 2020. Two personnel were on duty at the edge of the village towards Myanmar side occupying an abandoned building. The location is secure. The locals assist the police in performing their duty and cooperation with the locals is found very cordial. The locals informed the current location is most strategic.

3. Ngur:

SP Champhai visited the location on 8th April, 2020. The men were stationed on the side of the highway and were assisted by the 'locals on duty. The location covers the main entry point from Myanmar side. The men have enough requirements of provisions and received active cooperation from the locals.

4. Hnahlan:

SP Champhai visited the location on 8th April, 2020. Four personnel from Champhai PS are deployed to oversee the lockdown implementation at the town itself. They receive good cooperation from the public. Two personnel from 2nd IR Bn were deployed at the border near Tiau river which is around 7/8 kilometers from the town connected by a dirt road. The duties were assisted by 4 locals who are deployed in rotation. They have sufficient provisions and their accommodation, which is a jhum hut, is also found sufficient enough to withstand rain. If rain comes, accessing their location will be a problem and provisions may have to be delivered by foot.

5. Khuangphah:

SP Champhai visited the location on 8th April, 2020. Two personnel were deployed on the road side which covers the route connecting Myanmar. Locals including the village health worker, Village Council member etc assisted the duty on a daily basis. One tent was issued as the current accommodation is not found suitable in case of rain. Cooperation with locals is good and no problems were highlighted by the men on duty.

6. Vaikhawtlang:

Visited by SP Champhai on 8th April, 2020. Two personnel were deployed at the outskirts of the village around 2 kms away from the village. The location of the duty point was shifted from the bank of the Tiau river to the current location on the request of the villagers as this location covers more entry points. The duties help the locals in enforcing and regulating lock down and farming time etc. A number of locals assist the duties on a daily basis. Their accommodation, a waiting shed, is found sufficient to withstand in case of rain.

7. **Diltlang:**

SP Champhai visited the location on 8th April, 2020. Diltlang village itself is connected by a dirt road away from the main highway. The location of the deployment is right on the Tiau river which is around 4 kms from Diltlang village. One personnel is stationed in the village assisting the lockdown implementation and another is stationed at the Border along with 4 locals. Active cooperation is received from the locals. Silpauline were issued to improve the accommodation at the border as the hut occupied is not found sufficient to withstand heavy rain. In case of heavy rain, provisions may not be able to reach their location with vehicles. We may have to depend on the locals through head load.

8. **Farluichhuah:**

Pu Lalengliana Chhangte, Dy. SP (Hqrs) visited the duty post on 08.04.2020. Two personnel were deployed and assisted by 2 members from Ruantlang Branch YMA in rotational. They are accommodated at paddy field hut which is found sufficient even in case of rain. They erected barricade by cutting trees on the road. Coordination between police on duty and the local was found satisfactory.

9. **Zokhawthar:**

Zokhawthar duty post was visited by Pu Lalengliana Chhangte, Dy. SP (Hqrs) on 08.04.2020. The other 5(five) more check posts, such as, Khurte kai, Khupa kai - I, Khupa kai - II, Thirhlingli kai and Tuithap kai were also visited and each post were manned by police staff assisted by volunteers from village task force. Duty were accommodated at a temporary hut covered with silpauline. These huts were found not sufficient in case of raining.

Existing police staff posted at Zokhawthar PS from DEF and 2nd IR Battalion, Khawzawl are deployed in these various duty posts. Coordination between police staff and local are found cordial.


10. **Bulfekzawl:**

3 (three) police personnel from 2nd IR Battalion, Khawzawl were deployed at Bulfekzawl and was visited by Pu Lalengliana Chhangte, Dy. SP (Hqrs) on 08.04.2020. They were assisted by 4/5 volunteers from the local in rotation. They made temporary hut for performing duty and were provided silpauline. Cooperation with the locals is found good.

11. **Melbuk:**

Pu Lalengliana Chhangte, Dy. SP (Hqrs) visited duty post on 08.04.2020. Two personnel were deployed at the village and assisted by 4/5 volunteers from village task force in rotation. They are not having problem regarding accommodation and their coordination with the locals was also cordial.

Note: With temperature rising on a daily basis, mosquito problem is likely to afflict our men on the front line. Hence we have written to the health department and the DC's office for immediate issuance of mosquito nets (infused with repellents) and malaria medicines to our men. This matter will be pursued at the district level.
