

Meeting koh chhan sawiin ramri ven chungchang a, Ni 1.5.2020 a Chief Minister zahawm tak leh Home Minister zahawm tak hova sawihona an neih chungchang report pek pahin chumi atanga rawtna a neihte sawiho atan a chhawpchuak a, hetiangin;-

1. Ramri veng turin AR leh BSF te an awm na in an sipai neih te an tam tawk lova. Tin, anni hi CPMF an nih angin an in duty dan tur protocol fel leh rigid tak nei an ni. Chu vangin hmun tam takah duty point/ duty post an nei thei lova. Hemi avang hian Mizoram police leh kan volunteer ten CAPF ten an thutchilh theih loh ramri a kalkhan tam takah awmchilh in an veng mek a ni. Ramri a volunteer/VLTF (YMA/YLA/MTP) te chauh duty na hmun hi 196 niin, hmun 22 ah State Police chauh an duty a, hmun 139 ah State Police leh VLTF an duty ho bawk a. A vaiin ramri a duty na hmun hi 357 a ni a, (Assam Rifles leh BSF tel lovin). Police hi mi 808 leh VLTF duty hi mi 2250 vel an ni. VLTF 2250 zinga 564 hi Lunglei district-a India leh Bangladesh inri na a duty YCA (Young Chakma Association) member te an ni a, YCA (Young Chakma Association) member 127 Lawngtlai District a India leh Bangladesh inri na ah an duty bawk a, YCA te tel lovin hmun dang a VLTF duty te hi 1559 vel an ni a hriat a ni. (Duty na hmun zat leh mihring duty zat hi a ngai reng lo va, an danglam deuh reng a ni.)
2. Kan volunteer te hi hlawh nei lova thawk chhuak an nih bakah an mahni chhungkaw hna thawk/ ei zawng tu ber (main workforce) te an ni tlangpui bawk. Thla khat chuang zet kan volunteer te hi an duty tawh avangin an chau (stressed out) tawh ni a sawi a awm nual a. Tin lo lam hna tau teh lai a lo ni bawk si a, anni chhawk dan hi ngaihtuah a ngai ti a rawtna pawh a awm a.

3. Tin, ramri duty a thawk te hi ramri hrul khaw lian lo tete ami te an ni ber a (Vairengte leh Zokhawthar tih loh chu?). Tin lo neia ei zawng tamna khua te an lo ni deuh zel bawk a.
4. Volunteer duty te hi hlawh pek rawtna te a awm nual na a, hlawh peka duty tir tha ti lo tam tak an awm thung. Tin, volunteer te hi hlawh lo pe pawh ni teh reng ila, lo lama hna thawk tur an awm miau loh chuan lo lam hnain a tuar dawn thova (khaw lian lova chuan duh hun huna duh zat zat hlawhfa rawih tur an awm thin lova). Tin, volunteer te hlawh pek hian implication duhawm lo a hring palh thei tho bawk a. Tin, duty na hmun te hi phhuahchawp (make shift) taka din an nih avangin bualin leh intiarna tur changtlung leh duty te mamawh tui in tur, lighting arrangement ilo te pawh awm mumal lohna a ni. Tin, fur ruah tui a tam hunah chuan ramhnuia duty te tan harsatna pawh a tam tial tialin natna/ malaria ilo kai te pawh a hlauhawm thei bawk. Hengte avang hian ramri venga kan duty dan hi thlak danglam dan ngaihtuah a tulin a lang.

Rawtna :

- (1) Ramri kan venna chhan ber hi ram pawn atangin COVID-19 hri rawn pu lut an awm loh nan a ni a. COVID-19 hri paite an lo luh a Mizoram chhunga mi te zinga an kai darh loh nan a ni tih kan riruah awm ng het tlat se. Mihring vei vak hrim hrim duh lohna ni lovin hri keng darhtuah an tan palh theih avanga invenna thil mai a ni.
- (2) Kan hna thawktu ber thalai te'n ramri veng lova an hna pangngai an thawh theih hi kumin a thlai thar pangngai kan neih theih nan leh nakum lama buh-bal ei tur kan thar pangngai kan thar chhunzawm theih nan a pawimawh hle.
- (3) Khaw chhunga mi te pawh lova an khawsak chuan; ramri kâna lo lut turte'n hri an lo pai a nih pawhin an theh darh dawn lo tihna a ni a. Tin, ramri bula khuata pal tlang lo chuan Mizoram chhung khaw dangah an lut thei dawn lova.
- (4) Chuvangin duty na hmun hi ramhnuai a ramriah ni lovin ramri hnaih ber leh a dawtu kuaah te sawn ni se. Ramri hnaih ber leh a dawttu kuaah te check gate siam in khauh taka duty ni se.

Chairman in report leh rawtna a neihte member-te hriata a sawi zawh hian sawihona huri a hawng chhunzawm a. Sawihona hunah hian CYMA hruditute chuan an theih ang anga Sub-HQ, Group leh Branch YMA te flawh kual a an duty dari an zirchian thu report ngaihthlak a ni a. CYMA hruditute chuan ramri

venhim hna chu intlahdul hauh lova ngawrh taka venchhunzawm zel tha an tih thu leh ramri hrula Task Force duty te thlak tur pawhin; kawngtum tinah CYMA ruahmanna in YMA member volunteer intirh thin a nih thu leh chhunzawm reng tum a nih thu report ngaihthlak a ni bawk.

CYMA hruaitute hnena atanga report ngaihthlak zawk hian sawihona neih chhunzawm a ni a, uluk leh ngun taka sawiho a nih hnuah a hnuia thutlukna leh rawtna te hi siam a ni:-

- (i) Mizoram hmun hrang hrang a tlawm ngaia venhim hna thawktute avang in he hripui COVID-19 lakah hian kan ram pawh kan la him rih niin a lang a, hetih mek lai hian kan hmalam hun tur hi hriat a nih loh avangin nitin eibar zawn na khaihlak si lova ramri a venhim hna fei leh tlo taka kalpui a nih theih nan, a remchan dan anga ruahmanna siam theuh tura Tlawmngaia duty te hnena ngenna leh lawmthu sawina Press Release a hnuai ami ang hian siam nghal a ni.
