## MINUTES OF THE MEETINGTO DISCUSS MATTER RELATING TO SUPPLY CHAIN MANAGEMENT OF ESSENTIAL COMMODITIES DURING LOCK DOWN **PERIOD**

Date & Time

: 26.03.2020 (Thursday) @ 10:00 a.m.

Venue

: Chief Secretary's Conference Hall

Chairman

After welcoming the members, the Chairman informed the meeting that the biggest challenge after lock down to contain contagious corona virus (COVID-19) will be supply chain management of essential commodities in the states. He also stated that it is important that local farmers are able to go to their farms/fields and harvest their vegetables and bring it to the market for sale within Mizoram.

The problems faced by the Truck drivers in delivering the commodities to their destinations as reported by Secretary, Food, Civil Supplies& Consumer Affairs (FCS&CA) were also discussed. After due discussion and deliberation it was decided as below:-

The flow of essential commodities into Mizoram after the lock-down as compared to the period before the lock-down may be analysed by Director, FCS&CA and assess situation. The FCS&CA Department may come up with measures to mitigate the problem if the flow of essential goods has reduced.

2. Arrangements may be made in consultation with the wholesale traders of Mizoram to import adequate quantities of essential commodities into Mizoram to avoid any shortage situation. If required, the State Police shall provide assistance for safe transportation of these commodities from outside.

3. Arrangement for reporting and redressal of any problem faced by the Truck Drivers carrying essential commodities should be put in place and made known to all relevant(transport) associations, so that the truck owners and drivers have more confidence about their safety etc. FCS&CA Department shall take the responsibility for putting this system

in place.

- 4. The Director, FCS&CA will make logistic plan for supply chain and report the logistic details of Trucks carrying essential commodities to the concerned Local Task Force.
- 5. The Director, FCS&CA in association with the Director of Commerce and Industries, Director of Economics & Statistics and Commissioner of AMC shall assess the present stock position with the whole-sellers of essential commodities that usually come from outside Mizoram and make contingency plans for avoiding crisis of shortage.
- 6. The Commissioner & Secretary, FCS&CA who is the Chairman of the Task Force on Commodities constituted on 18th March,2020 shall guide and supervise this entire exercise.
