#### Terms of Reference:

- a) To collect, collate and analyse information, articles, Government Order/Notifications/Circulars issued on COVID-19 that may be of importance and interest to the public.
- b) To prepare a daily Bulletin and press note containing relevant information pertaining to COVID-19 and various action taken to contain COVID-19.
- c) To ensure wide dissemination of the Bulletin via Social Media and other mass media.
- d) Will endeavor to create a separate web portal or create mobile applications or other web-based applications page for verification of information pertaining to COVID-19.
- e) To evolve a mechanism whereby the existing state Government web portal is updated regularly on information regarding COVID-19.
- f) Highlighting the role of Civil society and NGOs in the war against COVID 19 as well as IEC materials will also be the task of this group.
- g) The task group shall ensure that only verified information is posted in the Bulletins.
