CHECK POINT VISIT OF DAVID J BYHNADAOLAI, SDPO, SIAHA DISTRICT.

In pursuance of IGP (L&O) order vide No. PHQ/IGP(L&O)73/COVID-19/2020/1117 Dt 6.4.20 and SP Siaha office order vide No.D/131/R0-SHA/2020/408 Dt.7.4.20, self visited 3(three) Covid 19 check points of Siaha police/VLTF/Assam Rifles within Siaha district by assessing their day to day performances and the challenges faced by them. I also delivered some basic some needs like rice, eggs, cooking oil, masks etc for their daily needs and protection.

8.4.20: 6.40 Am- Self left Siaha for Noaohtla and reached the same @ 8.00 am. I met with Chairman VLTF, VCP Pu Lalhmachhuana and YLA president Pu R. Sanghuma. I proceeded to visit 3 (three) 3rd Bn MAP personnel who are currently performing 24x7 duty at border crossing at Tuipui (Kolodyne river) located @ 14 kms from the village. They stay at a shed constructed with local materials which is being upgraded in view of the coming rainy season. At least 2 to 4 VLTF members also perform 24x7 duty in collaboration with police personnel. VLTF and police cooperation is excellent and the overall performance is found satisfactory. They have no problems/hurdles to report in performing their duty.

Apart from this, 2 NCOs+7 sepoys of 17 AR personnel are also stationed at Noaohtla village and are currently lodged at Primary School III. The AR personnel are not stationed at the border and they perform patrolling at random. They also go the border check point whenever transportation is available.

11.00 Am: Reached Lobo village. The village is manned by Lobo Out-Post personnel consisting of 1 SI, 1 hav, and 3 constables. There are three VLTF check points- two at both approaches of the village and one inside the village. The OP also maintains a check point on the main road which is manned 24x7. They have no problems/hurdles to report in performing their duty.

17 AR personnel consisting of 1 PC (subedar), 4 NCOs and 15 sepoys are stationed at their permanent camp in the village. Apart from these, 5 (five) AR personnel (1 NCO+4 sepoys) perform 24x7 duty at Tuipui (Kolodyne river) border crossing located @ 9kms from the village.

1.30 Pm: Reached Iana village. I met with the chairman VCP L.C Lalrinchhunga and some members of the VLTF and had a brief interaction with them. The village is manned by 1

(one) MRP and 2 (two) MAP personnel. There is one VLTF sheck point on the main approach to the village which is manned 24x7 by both police and VLTF personnel. The VLTF personnel performs daily duty at Tuipui (Kolodyne river) crossing located @ 8kms from the village from 8am to 5pm. Police personnel also performs the same duty 3-4 times a week in collaboration with VLTF personnel. VLTF and police cooperation is excellent and the overall performance is found satisfactory. They have no problems/hurdles to report in performing their duty.

Apart from this, 1 NCOs+4 sepoys of 17 AR personnel are also stationed at Iana village. The AR personnel are not stationed at the border and they perform patrolling at random.

2.15 Pm: Left Iana for Siaha and reached Siaha @ 6.00 PM.
