INSTRUCTIONS TO HOTELS & RESTAURANTS IN MIZORAM

In the interest of public safety, and in pursuance to the Government's instructions for dealing with the Novel Coronavirus (Covid-19) pandemic, the Department of Tourism, Government of Mizoram hereby issues the following instructions to all private establishments/facilities classified as hotels and restaurants in Mizoram for strict compliance and until further orders:

- 1. Wash basin with clean water and soap/hand wash must be installed near the entrance and all customers must be instructed to clean their hands before entering the facilities.
- 2. Hand Sanitizer with atleast 60% alcohol content must be placed at the reception/payment counter of the facilities. Avoid placing toothpicks and mouth fresheners at counters.
- 3. All furnitures, floors, liveries in must be properly disinfected at regular intervals. Door handles, elevator buttons and toilets must be clean at all times.
- 4. All tables and chairs in restaurants must be arranged in such a way that there is a safe distance between seats, preferably no less than 1 meter apart. Restaurants should not entertain customers exceeding the minimum safe distance capacity at a time.
- 5. Only clean utensils must be used to serve food. Chutneys/ketchups/condiments, water jugs/glasses and napkins must be served in need basis and not kept remaining at tables.
- 6. Hotels and restaurants should remain vigilant for customers with fever, coughing or breathing problems.
- 7. All service staff in hotels and restaurants must wear clean protective mask and gloves during working hours.
- **8.** All guests checking in at hotels are mandated to fill up **Self Report Form from new guests** as enclosed and the hotel authorities will be responsible for their daily submission to Tourism Department in soft copy through Whatsapp at 6009728238 or email at <u>mizoram.tourism@gmail.com</u>
- 9. Action will be taken against willful defaulters of the above instructions.
