NOTIFICATION

Subject: Constitution of COVID-19 Crisis Management System of Mizoram.

Whereas, the National Disaster Management Authority, vide order dated 24.03.2020, had directed Ministries/Departments of the Government of India, State Governments and State Authorities to take effective measures for ensuring social distancing to prevent the spread of COVID-19 across the country and for mitigation of the threatening disaster situation, while ensuring maintenances of essential services and supplies, including health infrastructure;

And whereas, the National Disaster Management Authority, vide the aforementioned Order had also ordered that necessary guidelines shall be issued by the National Executive Authority;

And whereas, the Union Home Secretary, in his capacity as Chairperson of the National Executive Committee, had issued Orders dated 24.03.2020, 25.03.2020 and 27.03.2020 with guidelines to implement lockdown measures for 21 (twenty one) days, effective from 25.03.2020, for the containment of spread of COVID-19 in the country;

And whereas, the Union Home Secretary, in his capacity as Chairperson of the National Executive Committee had issued Order dated 14.04.2020 for continued imposition of lockdown for a further period till 03.05.2020 and further issued Order dated 15.04.2020 consolidating revised guidelines for implementation of lockdown measures ;

And whereas, the undersigned, in his capacity as Chairperson of the State Executive Committee of the State Disaster Management Authority had also issued consequential Orders dated 25.03.2020, 26.03.2020, 28.03.2020 and 16.04.2020 for strict implementation of the lockdown measures while ensuring maintenance of essential services and supplies, including health infrastructure;

And whereas, the State Executive Committee is of the view that the existing response mechanism needs to be streamlined so as to promote better coordination among the various Task Groups/Teams and concerned Departments. Hence, the undersigned in his capacity

as Chairperson of the State Executive Committee, hereby notifies the *COVID-19 Crisis Management System* by dovetailing and integrating the existing response mechanism viz the State Level Task Force, Task Groups and various management Units and Teams formed under various Departments for combating COVID-19 outbreak in the state.

A daily report shall be submitted to the Chairman, COVID-19 Crisis Management Group based on the information gathered during the meeting. It shall be the responsibility of the Chairmen/Conveners/Nodal Officers etc of the Task Group/ Units/Teams etc to ensure the attendance of a representative who is well versed with the issues even in the absence of meeting notices.

<u>Weekly Review</u>: A weekly meeting may be called by the Chairman, COVID-19 Crisis Management System to assess progress of all the Task Groups/Teams. The meeting shall discuss new issues, concerns and developments arising out of the situation and make decisions accordingly. Assignment of roles: The Task Groups/ Teams may be assigned new roles and responsibilities as per the demands of the evolving situation.
