Subj: Facilitating return of stranded workers, students and travellers to Mizoram.

Sir/ Madam

As you are aware the implementation of the 21 day country wide lockdown from 25.03.2020 has left many Mizo students, workers and travellers stranded in various States across India. Many of these stranded persons have reported facing difficulties such as shortage of money, limited access to essential goods/services as well as demands for rent from landlords, discrimination by locals etc. Hence, their speedy and safe return to Mizoram where feasible is desirable. Thus, an opportunity to bring back persons stranded in Guwahati, Shillong, Silchar and other North East States may arise shortly. Therefore, I am directed to request you to make the following preparations immediately –

1. Information on stranded travellers in the format given below may be submitted to the undersigned destination-wise by 13.04.2020-

 All the persons listed above shall be instructed to fill up the Self Declaration form issued by H&FW Dept. in advance (copy enclosed). This form shall be submitted to H&FW personnel at the Screening point at Vairengte.

- 3. Such persons wishing to return to Mizoram must undergo 14 days compulsory Quarantine at Government Quarantine facilities in their own district as far as possible. It shall be the responsibility of the concerned DRC to ensure all the stranded persons are aware of this pre-condition. Home quarantine shall not be permitted under any circumstances.
- 4. In case of large number of stranded persons phase-wise movement may have to be planned. Hence, these stranded persons may not be released until clear cut readiness is received from the districts.
