Sir,

Your kind attention is invited to the subject and Notifications under reference wherein quarantine facilities identified by various DDMAs were listed.

Discrepancies have been observed between the notifications and the daily reports on quarantine facilities submitted by the districts. Also, there are glaring discrepancies between the daily reports submitted by the DC/DDMAs and Health & Family Welfare Department (Medical Control Room) with regard to the number of facilities in the districts, their respective capacities and the number of persons lodged in the quarantine facilities on the same date of report. For instance, as per the report of 23.04.2020 received from the DDMAs, there are 135 quarantine facilities in the State having a capacity of 2467 persons and the number of persons in the quarantine facilities on the said date is 181, whereas the Medical Control Room have reported the total number of quarantine facilities as 98, the total capacity as 2707 and the number of persons in the facilities as on the said date as 164. Health & Family Welfare Department are also sourcing their data from the districts (CMOs).

Such inconsistencies in our reports create confusion in further reporting and data management at the State level.

In order to have uniform data on matters pertaining to quarantine, I would like to request you to kindly revisit the list and the capacity of identified quarantine facilities of your district notified by this Department and to send the firm list of quarantine facilities and their respective capacities by **27.04.2020** by email at **usecydmr@gmail.com** so that a superseding Notification can be issued, if required.

With regard to the daily report of the number of persons in the quarantine facilities, you are requested to first cross-check the figures with the District Health authorities so that the figures coming from different sources in the district tally.

I would further request that the list of quarantine facilities reckoned by the Health authorities for submission of their daily reports be compared with that of the DDMAs since only the quarantine facilities approved by the State Executive Committee and notified by this Department will be taken into consideration while defraying expenditure from SDRF.
