NOTIFICATION

WHEREAS, in exercise of the powers conferred under Section 22(2)(h) of the Disaster Management Act, 2005, the undersigned in his capacity as Chairman, State Executive Committee, has issued an order of even number dated 25.3.2020 to all Government Departments, Bodies & Undertakings of the Government, Public & Private enterprises, with a direction to implement the containment measure specified in the order for prevention of the spread of COVID-19 in the State;

AND WHEREAS, consequent upon the implementation of the above mentioned containment measures and with a view to enhance the level of preparedness for prevention of the spread of COVID-19 in the State, there is a pressing need for comprehensive action and integrated response involving various Departments of the State Government, the undersigned in his capacity as the Chairperson, State Executive Committee and in exercise of the powers conferred under Section 22(2)(g) & (h) of the Disaster Management Act, 2005 hereby constitutes the following Task Groups to take measures as indicated below:

1. Task Group on Medicine & Medical Equipments:

Terms of Reference:

- a) To assess requirement of Medicine & Medical equipments for prevention & containment of the spread of COVID-19 & treatment of patients and ensuring timely action for their procurement.
- b) To identify individual requirement of different hospitals at Sl. No (a) above, and arrange for their timely delivery to each of the hospitals and medical institutions.
- c) In case of requirement, the Task Group may render assistance to private hospitals in obtaining necessary supply of medicines and medical equipments.
- d) The Task Group shall observe due diligence in effecting the procurement by following the provision of the GFR/CTR and standing instruction of the State Government in the Finance Department. However, depending on the urgency of the situation, the provision of section 50 of the Disaster Management Act, 2005 may be invoked in case of emergency procurement. However, proper records of information and justification shall be maintained.

Terms of Reference:

- a) The Task Group shall oversee arrangements of temporary shelters and provision of food etc. for the migrant workers and stranded travelers within the state.
- b) The Task Group shall collect necessary information about the migrant workers/ stranded travelers belonging to the state in other parts of the country and undertake necessary intervention for the safety and wellbeing in liase with concerned state government.
- c) The Task Group shall suggest any other measures deemed proper for the welfare and safety of the migrant workers and stranded travelers.

- b) The Task Group shall assess the availability, arrange for and streamline the movement of passenger service vehicles and goods carrying vehicles for unhindered movement of essential commodities and that of personnel exempted from the purview of the containment order issued by the State Government.
- c) The Task Group shall make contingent arrangement for availability of vehicles as mentioned at Sl. no. (a) and (b) above to be deployed in case of exigency/ emergencies.

However, the provision of section 50 of the Disaster Management Act, 2005 may be given effect in case of emergency procurement. However, proper records of information and justifications shall be maintained.
